Fractional Access to Private Companies, Sports Teams, and Alternative Assets — On-Chain.

Abstract

TickTick is a sentiment-based speculative market protocol built on the Base network. It enables users to trade their beliefs about the valuations of private companies, sports franchises, and emerging ventures — without representing ownership or equity. Each market reflects public sentiment and trading activity, creating a dynamic, transparent measure of global interest.

The Market Problem

Traditional private equity is exclusive, opaque, and illiquid. Retail participants are barred by high minimums, limited access, and outdated structures. Meanwhile, market sentiment toward private companies remains untapped as a tradeable metric.

The TickTick Solution

TickTick introduces sentiment markets — tokenized digital representations of public speculation on private company valuations. For example, a market like \$SPACEX allows users to trade based on perceived valuation growth or decline, using USDC as collateral. These tokens represent sentiment, not securities, offering a transparent and fair way to express belief in innovation.

The \$TICK Token

The \$TICK token governs the TickTick ecosystem. Holders can propose and vote on new sentiment markets, stake for rewards, and receive fee discounts across the platform. \$TICK aligns community and protocol growth through decentralized governance.

Technical Architecture

Built on Coinbase's Base network, TickTick leverages EVM-compatible smart contracts and gas-relayer infrastructure to ensure smooth, low-fee transactions. Users trade using USDC while the relayer absorbs network gas, providing a nearly gas-free experience with full transparency on-chain.

Revenue Model

TickTick earns revenue from a small percentage of transaction fees, market creation costs, and premium tiers. Additional revenue is generated from staking spreads and treasury yield programs managed by governance.
